VANDALISM EXCLUSION

This endorsement modifies insurance provided under the following:

- FARM PROPERTY – FARM DWELLINGS, APPURTENANT STRUCTURES AND HOUSEHOLD PERSONAL PROPERTY COVERAGE FORM
- FARM PROPERTY – BARNs, OUTBUILDINGS AND OTHER FARM STRUCTURES COVERAGE FORM
- CAUSES OF LOSS FORM – FARM PROPERTY
- FARM PROPERTY – OTHER FARM PROVISIONS FORM – ADDITIONAL COVERAGES, CONDITIONS, DEFINITIONS
- LIVESTOCK COVERAGE FORM
- MOBILE AGRICULTURAL MACHINERY AND EQUIPMENT COVERAGE FORM

- A.** The provisions of this endorsement apply to the "insured locations" and covered property shown in the Schedule.
- B.** The following applies to:
 - Causes Of Loss Form – Farm Property
 - Livestock Coverage Form
 - Mobile Agricultural Machinery And Equipment Coverage Form

The following is added to the **Exclusions** Section and therefore is not a Covered Cause of Loss:

VANDALISM

But if vandalism results in a Covered Cause of Loss, we will pay for the loss or damage caused by that Covered Cause of Loss.
- C.** The following applies to:
 - Farm Property – Other Farm Provisions Form – Additional Coverages, Conditions, Definitions
 - Mobile Agricultural Machinery And Equipment Coverage Form

Vandalism is deleted from the "Specified Causes of Loss" definition.
- D.** Vandalism is deleted from the following provisions:
 1. Paragraph **A.** Trees, Shrubs, Plants and Lawns under Section **II** – Coverage Extensions in the Farm Property – Farm Dwellings, Appurtenant Structures And Household Personal Property Coverage Form.
 2. Paragraph **B.** New Construction under Section **II** – Coverage Extensions in the Farm Property – Barns, Outbuildings And Other Farm Structures Coverage Form.
 3. Paragraphs **1.p.** and **1.q.** of **D.** Covered Causes of Loss – Special in the Causes Of Loss Form – Farm Property.
- E.** The following applies to Mobile Agricultural Machinery And Equipment Coverage Form:
 - Vandalism is deleted from Paragraph **s.** of **B.2.**, Other Exclusions.
