THIS ENDORSEMENT CHANGES THE POLICY. PLEASE READ IT CAREFULLY.

EXCLUSION

There is no coverage for loss or damage caused by theft or piliferage of property from an automobile unless the property was in a locked, fully enclosed compartment which is a part of the automobile, and unless there are visible signs of forcible entry into the locked compartment.
